SCALE OF PAY- The appointment will be initially on contractual basis carrying a consolidated pay of Rs.5200/- + Grade Pay of Rs.1800/-(Pre-revised). The salary/scale of pay may vary according to the decision of the Government from time to time.

- iii) **MINIMUM EDUCATIONAL QUALIFICATION:** - The minimum educational qualification for the post is HSC/Matriculation or equivalent qualification with Amin Training Certificate from recognised institution.
