SCALE OF PAY-

PTI- The appointment will be initially on contractual basis carrying a consolidated pay of Rs.5200/- + Grade Pay of Rs.2000 (Pre-revised)

PTI-cum-Hostel Superintendent- The appointment will be initially on contractual basis carrying a consolidated pay of Rs.9300/- + Grade Pay of Rs.4200/-(Pre-revised). The salary/scale of pay may vary according to the decision of the Government from time to time.

PTI- Appointment is contractual initially to be guided by the Odisha Group-C & Group-D (Contractual Appointment) Rules, 2013 notified vide G.A. Department Notification No. GAD-SC-Rules-0009-2013-32010/Gen dt. 12.11.2013.

PTI-cum-Hostel Superintendent- Appointment is contractual initially to be guided by the Odisha Group-B (Contractual Appointment) Rules, 2013 notified vide G.A. Department Notification No. GAD-SC-Rules-0061-2013-1147/Gen dt. 17-01-14

ELIGIBILITY

- UPPER AGE RELAXATION** limits 5 years in case of SC,ST, SEBC and Women candidates,10 years for PWD candidates, cumulative age relaxation of 10 years over & above the normal age relaxation for PwD Candidate in SC & ST category, total period of service rendered in Defence Forces in case of Ex servicemen and up to 45 years as on 01.01.2017 for in-service contractual employees as per provisions contained in Odisha Contractual Appointment Rules 2013.
- MINIMUM EDUCATIONAL QUALIFICATION:-** PTI- +2 with CPED. from a recognized University. The candidates having higher qualification are eligible to apply for the post.
PTI-cum-Hostel Superintendent-BPEd. form a recognized University..
- PLAN OF EXAMINATION:** i) Main Written Examination -100 marks -1hr 30 mins- Objective Type (General Studies-50 marks & CPED. Course -50marks)
ii) Certificate verification

There will be no Viva-Voce Test.

Only candidates having BPEd. qualification will exercise their option for two posts in order of preference.
