ORDER


Sri Arupananda Nayak bearing Roll No.07150200539 and Sri Abhinandan Barik bearing Roll No.19150200051 were the candidates of Combined Police Service Examination 2015. While appearing the main written examination at Govt. High School, Unit-6, Bhubaneswar on 19.05.2018 the above named candidates were found in possession of mobile phones & Textual Materials in the examination hall.

The Additional District Magistrate-Cum- District Superintendent, Bhubaneswar, Centre Superintendent, Govt. High School, Unit-6, Bhubaneswar, observer of the examination centre as well as the invigilator of the Examination Hall have reported that both the candidates were found in possession of one Mobile Phone each and textual material in the examination hall after commencement of the examination which were banned inside the Examination Centre/Hall.

As such the Commission after due consideration of the report of concerned officers and under provision of Rule-18 of OSSC Rule,1993 read with the Instruction to the candidates in the Admission letter as well as the General Notice issued to the candidates vide Order No.1336/OSSC dtd.07.05.2018 (available in the official website of the Commission) for guidance of the candidates during the examination, found the above candidates namely Sri Arupananda Nayak bearing Roll No.07150200539 and Sri Abhinandan Barik bearing Roll No.19150200051 to have adopted unfair means during the examination and have violated the Instructions contained in the Admission letter and therefore found guilty u/r 18(vii) and 18(xi) of OSSC Rule,1993.

The Commission in exercise of the power under Rule-18 of OSSC Rules, 1993 have decided to debar the above named candidates from appearing the rest papers of CPSE-2015 examination to be held on 20.05.2018 for which they are candidates.






