CONDITIONS OF SERVICE: Appointment is contractual initially to be guided by the Odisha Group-B (Contractual Appointment) Rules-2013 notified vide G.A. Department Notification No. 1147-GAD-SC-Rules-0061-2013/Gen. dated 17th Jan 2014.

ELIGIBILITY:

- i) Age: Must not be below 21 years and above 32 years of age as on 1.1.2016.
- ii) Upper age relaxation: 5 years in case of the Candidates belongs to SC, ST, SEBC, Women categories. 10 years for PWD candidates & total period of service rendered in Defence Forces in case of Ex-servicemen.
For in-service contractual employees as per provisions contained in the concerned Rules, they must be within 45 years of age as on 01.01.2016.
- iii) Minimum Educational Qualification: - The candidate must have passed Bachelor's Degree from any recognised university.

Viva Voce Test- 30 Marks.
